6. Towong Fire Management Planning Committee – Update – CFA – Trever Ebbels

Busy February - Meeting on June 8 discussed new MFMP fine-tuning still to be done. Hope to have it ready to present at the Sept MEMPC.

7. **MEMP Amendments –** Amanda Pagan - TSC

Red Cross email be updated to a generic email rather than a specific person.

TSC Proposes the removal of the Corryong Secondary College from the MEMP as the secondary relief centre site due to operational constraints.

TSC Proposes the removal of the Corryong Recovery Hub from the MEMP as a proposed relief centre site due to the closure of the Recovery Hub and uncertainty around the site's tenancy yet to be resolved.

Upper Murray Events Centre would become the Primary site and the Youth Club Hall the

secondary site. Parking constraints do not see the Memorial Hall being the ideal secondary site alternative.

9. Critical Infrastructure Clearance – Amanda Pagan – TSC

Concerns from TSC that key Telstra towers are not being maintained adequately with the fire breaks.

Trevor Ebbels - Concerns have been raised at the MFMPC as well. CFA reps are going back to their brigades to provide data on what needs to be done & report to MEMPC to forward to the REMPC. Photos to document works required for clearance area.

Council may be able to use funding from Telstra for Mount Elliott Clearance.

11. Resilient Buildings – Amanda Pagan – TSC

Council have identified key buildings across the municipality that need several upgrades in terms of making them more resilient for the communities they are located in.

Resilient means, Do they have solar? Do they have Batteries? Do they have water tanks? Do they have any communications infrastructure?

The aim is to give the communities a meeting place to return to when it's safe to do so.

Letters have been sent to the Committees of Management (CoM) of the identified halls offering different resilience packages, which the CoM may or may not accept.

A pool of generators is being purchased by Council and strategically located throughout the Shire during High-risk periods. Included in the package offer to the CoM of the halls is an electrical upgrade to ensure generator compatibility.

This process will also give TSC a full overview of what all relevant community facilities ie. how much water they have, and how much power they have, which will aid in the delivery of Relief and Recovery arrangements.

13. General Business

Trevor Ebbels - Adrian Gutsche is no longer with CFA's District 24 – Brett Myers is currently the acting AFCO.

There has been a marked increase in escaped burn-offs since FDPR ceased. Three charges have been laid.

Brigades prescribed burns were delayed due to dry conditions.

Charlie Sexton – The new emergency management training courses that were announced are now not happening. Budget constraints unfortunately have pushed these back.

La Nina watch coming into spring.

New Community Resilience Co-Ordinator started, Glenn Mercer replacing Tarryn Firman.

Corryong crew member training has started, David Yule is the Corryong Unit Controller.
